

**BYLAW #2019-02
VILLAGE OF ACME
IN THE
PROVINCE OF ALBERTA
PROPERTY TAX BYLAW**

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE VILLAGE OF ACME FOR THE 2019 TAXATION YEAR.

WHEREAS, the Village of Acme has prepared and adopted detailed estimates of municipal revenue, and expenditures as required at the Council meeting held on May 16th, 2019 and;

WHEREAS, the estimated municipal expenses and transfers (not including requisitions) set out in the budget for the Village of Acme total \$1,560,104, and;

WHEREAS, the estimated municipal revenues from all sources other than property taxation total \$720,147 And the balance of \$839,957 is to be raised by general municipal taxation, and:

WHEREAS, the assessed value of all taxable property in the Village of Acme as shown on the assessment roll and the taxation rates are as follows:




