BYLAW #2018-09 VILLAGE OF ACME IN THE PROVINCE OF ALBERTA PROPERTY TAX BYLAW

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE VILLAGE OF ACME FOR THE 2018 TAXATION YEAR.

WHEREAS, the Village of Acme has prepared and adopted detailed estimates of municipal revenue, and expenditures as required at the Council meeting held on May 14th, 2018 and;

WHEREAS, the estimated municipal revenues from all sources other than property taxation total \$583,110. And the balance of \$816,747. is to be raised by general municipal taxation, and:
