**A BYLAW TO AMEND BYLAW 2023-06 BY CHANGING THE DESCRIPTION OF THE ROAD CLOSURE PLAN.**

**AND WHEREAS** the Municipal Government Act, Chapter M26.1, Revised Statutes Of Alberta 2000, as amended and Section 63(2)(g) permits changes to the substance of the bylaw to bring out more clearly what is considered to be the meaning of Bylaw 2023-06.

The legal description of Bylaw 2023-06 is described as:

**DESCRIPTION:**

The road closure is shown as AREA 'A' and is +/- 0.887ha in Appendix A. The north portion of the road runs east-west from the northeast edge of Lot 1 Block 4 Plan 991-3515 to just north of the northwest edge of Lot 4 Block 6 Plan 991-3515: Extending south to the north edge of Lot 4 Block 5 Plan 991-3515 and on the south portion going east-west as it runs from the northwest edge of Lot 5 Block 5 Plan 181-1139 to the northeast edge of Lot 5PUL Block 5 Plan 991-3515. (The area is highlighted by a bold border).

The legal description is amended in Bylaw 2023-06 by changing the legal description and is described as:

**DESCRIPTION:**

The road closure is shown as AREA 'A' on PLAN 2311873 in Schedule A.

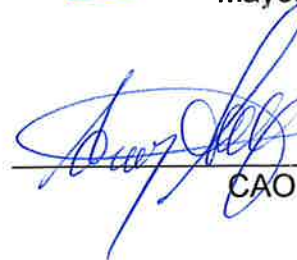

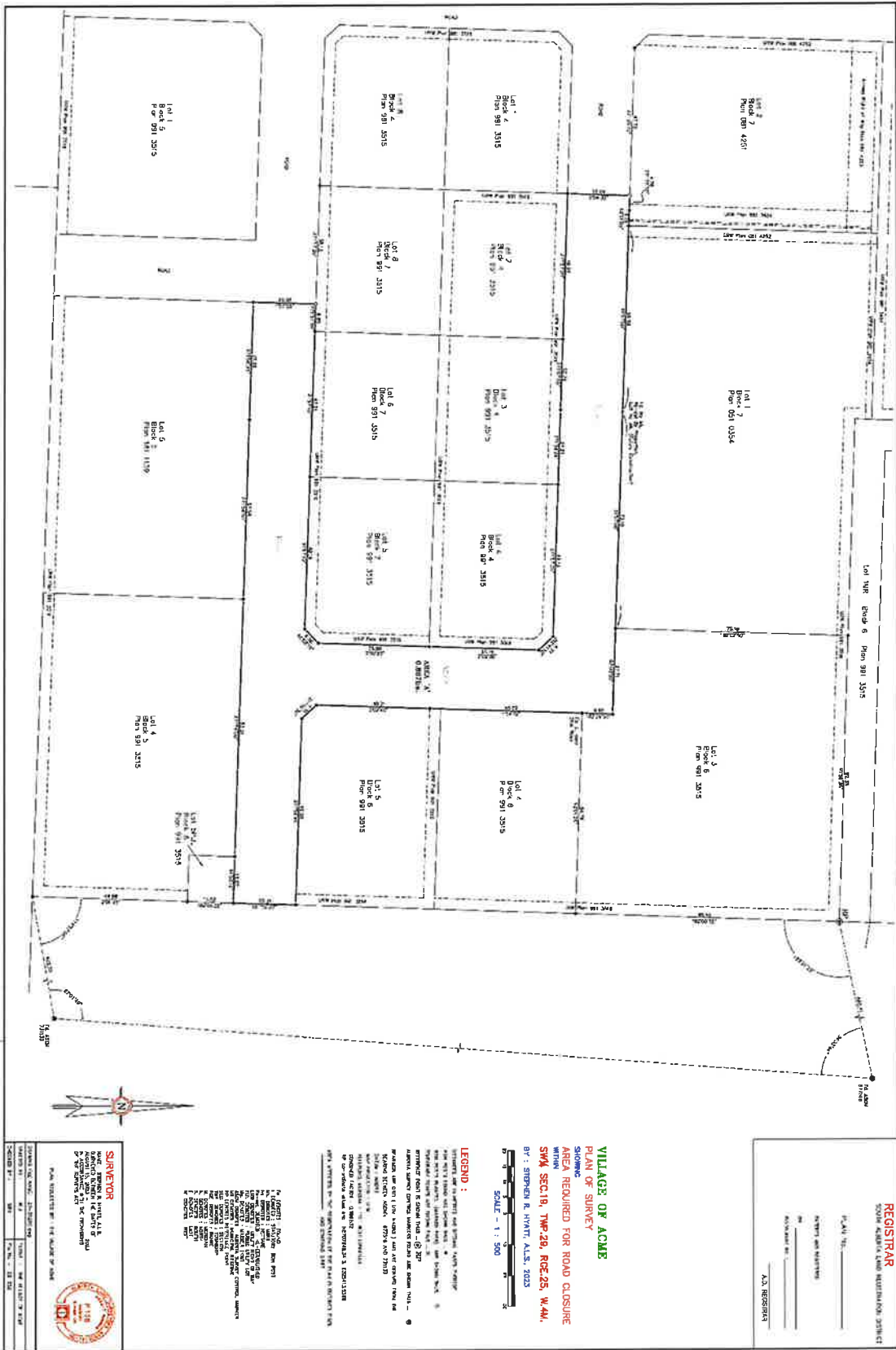
