BYLAW TO REPEAL BYLAWS

A BYLAW FOR THE PURPOSE OF REPEALING BYLAWS NO LONGER IN EFFECT.

WHEREAS the *Municipal Government Act*, RSA 2000, c. M-26, as amended or repealed and replaced from time to time, provides the Council of the Village of Acme the authority to pass bylaws as well as repeal bylaws;


