FIRE BANS

For the 2023 season, the Village of Acme will be notifying residents of any fire advisories or fire bans through the Village of Acme website. www.acme.ca

WHAT IS A FIRE ADVISORY?



A fire advisory means no open fires or fires requiring a burning permit. An advisory only allows for, recreational

fires in covered fire pits, approved fire pits in campgrounds and parks, propane, natural gas, charcoal, and pellet barbeques, grills, or smokers. All other fires are not permitted until the advisory is lifted.

WHAT IS A FIRE BAN?



A fire ban means all fires of any type using any form of fuel are prohibited in the Village.

BACK YARD FIRES / CAMPFIRES

Before having backyard fires, please check the Village Website to see if there is a fire restriction or ban in effect. Please ensure all campfires are:

- Supervised by a responsible adult (18 years or older);
- In an acceptable fire pit;
- Do not exceed 0.6 meters above the fire pit / enclosure; and
- Fully extinguished when done.

Acceptable Fire Pit means an outdoor receptacle that meets the following specifications:

- a minimum of two and one half (2.5) meters clearance, measured from the nearest firepit edge, is maintained from buildings, fences, property lines, or other combustible material.
- the fire pit installation has enclosed sides made from bricks, concrete blocks, heavy gauge metal, or another non-combustible material; and
- a spark arrestor mesh screen with openings no larger than one and one quarter (1.25) centimeters and constructed of expandable metal, or equivalent non-combustible material, is used to cover the fire pit opening in a manner sufficient to contain and reduce the hazards or airborne sparks.

FROM THE VILLAGE OFFICE

PROPERTY TAXES DUE

Property Tax are due on Friday, July 28 by 4;00 pm.

If you are on TIPPS, your new payment amount will take effect beginning with July's payment.

WATER UTILITY BILLS / PAYMENTS

Water Utility Bills for the months of May and June are due July 31, 2023.

Village of Acme Utility Bills are only sent out every second month. However, to make it easier to remember to pay this bill payment, residents can make monthly payments through online banking. The payments made during the off months will show as credit on your next bill.

FROM PUBLIC WORKS

MOWING / SIDEWALKS

When moving your lawn, please do not blow your lawn clippings on the sidewalks / roads as they can block the storm drains. Please blow all lawn clippings back onto your lawn when you are done mowing.

PETS IN THE VILLAGE

Please remember to properly care for your pets and adhere to the Animal Control Bylaw #2018-15 regarding pets in the Village. The following are a few excerpts from the bylaw as a reminder to all pet owners in the Village:

Part 5 - LICENSING OF ANIMALS

Number of Animals

5.14 No person shall keep, harbour, or have more than three (3) dogs or three (3) cats or a total of four (4) animals per dwelling unit.

Part 6 - RESPONSIBILITY OF OWNERS

Running at Large

- 6.1 The Owner of an Animal shall:
 - 6.1.1 ensure that the Animal is not running at large;
 - 6.1.2 ensure that the Animal, when not on the Owner's property, is leashed and under the control of a competent person; and
 - 6.1.3 ensure that when an Animal defecates on any public or private property other than the property of the Owner, the feces shall immediately be removed and properly disposed on in a garbage receptacle.

Nuisance Behaviour

6.6. The Owner of an Animal shall ensure that such Animal shall not bark, howl, or otherwise make or cause a noise which disturbs any person(s).



Maximum of 4 pets. No more than 3 of either breed (cat / dog).

Always controlled @ on a leash unless 🧎 in fenced yard.





Clean up all animal poop off any property not owned

No excessive barking that will disturb others.
